



The City Council of the City of Midfield, Alabama met in regular session on Monday, February 26, 2007, at 7:30 P.M. with Mayor Gary Richardson presiding.

Councilmember Terry Adams gave the invocation.

Cedric Brown called roll, the following members were present: Terry Adams, Janice Anderson, Jimmie Robinson, Velma Johnson, and Mayor Gary Richardson. Cedric Brown acted as clerk. A quorum being present the meeting was opened for the transaction of business.

Approval of published minutes from last Council meeting: Councilmember Janice Anderson made the motion to approve the published minutes from the last regular Council meeting. The motion was seconded by Councilmember Velma Johnson. A roll call vote resulted in a unanimous vote.

Approval of payment of bills: Councilmember Velma Johnson made the motion to suspend rules of immediate consideration of payment and Councilmember Janice Anderson seconded the motion. Councilmember Jimmie Robinson made the motion to approve the payment of the February #2 bills totaling \$ 63,680.52. The motion was seconded by Councilmember Velma Johnson. A roll call vote resulted in a unanimous vote.

Approval of Resolution No. 2007-10: Authorizing the Mayor to enter into an agreement with GT Consultant for City Inspections. Councilmember Velma Johnson made the motion to approve Resolution No.2007-10. The motion was seconded by Councilmember Janice Anderson. All members present voted aye passing the motion unanimously.

Approval of Resolution No. 2007-11: Authorizing the Mayor to enter into an agreement with Clara Prevo Consultant as a Community/ Economic Development Coordinator. Councilmember Janice Anderson made the motion to approve Resolution No.2007-11. The motion was seconded by Councilmember Jimmie Robinson. All members present voted aye passing the motion unanimously.

Approval of Appointment of Erica Canada and Stacey Daniels to the Midfield Library Board.

Councilmember Velma Johnson made the motion to approve the appointment. The motion was second by Councilmember Terry Adams. All members present voted aye passing the motion unanimously.

Report from the Mayor: The Mayor reported that the construction for the CVS Drug Store which will be located on the former site of Chevron/ Carnaggio's has begun.

Report from the Council: Councilmember Janice Anderson reported that the Girl's Basketball Team Tournament Game is 9:00 A.M. at the B.J.C.C. Councilmember Velma Johnson spoke on next Magic City Stroke Meeting.

Open Meeting to the Public: Richard Shows gave a report on the condition of Midfield Library. He stated that there are mice in the attic among other building related issues. The Mayor stated that although we provide funding to the Library the City Of Midfield does not own the Library. He referred Mr. Shows to the Library Board which is a separate and distinct Governing Body of the Midfield Public Library.
