

## Meeting Minutes City of Midfield, Alabama City Council

The City Council of the City of Midfield, Alabama met in regular session on Monday, October 11, 2010 at 7:00 pm with Mayor Richardson presiding.

Council-member Velma Johnson gave the invocation.

Tameeka Ephriam called roll. The following members were present: Reginald Wilson, Terry Adams, Janice Anderson, Velma Johnson and Jimmie Robinson. Tameeka Ephriam acted as clerk. A quorum being present the meeting opened for transaction of business.
