

Meeting Minutes City of Midfield, Alabama City Council

The City Council of the City of Midfield, Alabama met in regular session on Monday, October 12, 2009 at 7:00 p.m. with Mayor Richardson presiding.

Councilmember Janice Anderson gave the invocation.

Tameeka Ephriam called roll. The following members were present: Reginald Wilson, Janice Anderson, Terry Adams and Jimmie Robinson. Tameeka Ephriam acted as clerk. A quorum being present the meeting opened for transaction of business.
