Approval of Agenda. Councilor Janice Anderson made a motion to approve the agenda. The motion was seconded by Councilor Velma Johnson. All members present voted “aye”, passing the motion unanimously.

Approval of Minutes from last regular scheduled meeting: Councilor Velma Johnson made a motion to approve the minutes. The motion was seconded by Councilor Janice Anderson. All members present voted “aye”, passing the motion unanimously.

Department Heads: Jeff Zisette, Public Works Director, informed attendees they had 175 weed violations this year; Eighty three were cut by property owners, eighty eight were cut by city staff and four still pending. He attended Storm Matter Management Authority Meeting and they advised on new reporting system.
