Report from the Mayor: The Mayor announced that the Grand Opening of Midfield Splash Pad is scheduled for May 7, 2011 between the hours of 12:00 p.m. to 2:00 p.m. Refreshments, games, moonwalks and entertainment will be provided. The Mayor announced that the Planning and Zoning Board approved an application from the Jefferson County Health Department to have two parcels of land rezoned from residential to commercial use. The Jefferson County Health Department desires to turn that land into a park. The Mayor yielded the floor to Larry Weygand, the surveyor for the Health Department; he stated that there will be no fronting on Nail Street. He also stated that it will give the Health Department an opportunity to develop green space for future use. The name of the new facility will be West Jefferson Health Department and will employ a minium of 1500 employees and the project cost is \$15,000,000.00. The Mayor announced Habitat for Humanity in conjunction with Americorps will be in the City of Midfield May 9-13, 2011 revitalizing homes. The Mayor announced that Johnathon Staton from Valley Creek Clean Up is present to give a presentation. Freshland Water Trust has given them permission to host a Valley Creek Clean Up along B.Y. Williams Drive and High School Road. He is aking for volunteers to help with this endeavor.
