



Meeting Minutes City of Midfield, Alabama City Council

The City Council of the City of Midfield, Alabama met in regular session on Monday, April 26, 2010 at 7:00 pm with Mayor Pro Tem Janice Anderson presiding.

Council-member Velma Johnson gave the invocation.

Tameeka Ephriam called roll. The following members were present: Reginald Wilson, Terry Adams, Janice Anderson, Velma Johnson and Jimmie Robinson. Tameeka Ephriam acted as clerk. A quorum being present the meeting opened for transaction of business.

Approval of published minutes from last Council meeting: Council-member Velma Johnson made the motion to approve the published minutes from the last regular Council meeting. The motion was seconded by Council-member Reginald Wilson. All members present voted aye passing the motion unanimously.

Approval of payment of bills: Council-member Reginald Wilson made a motion to suspend the rules for immediate consideration and pay April #2 bills for \$34,187.66. The motion was seconded by Council-member Velma Johnson to approve the payment of April #2 bills for \$34,187.66. All members present vote aye passing the motion unanimously.

Council-member Terry Adams stated that he has been in communication with the Police Department and they reported that things are getting better at the High School.

Council-member Jimmie Robinson inquired about the progress of City Computers concerning bookkeeping.

Council-member Janice Anderson reported that Steve Ellis, with City Computers stated that he has 90 % of the records up to date and will be at the next council meeting to give a report.

Open Meeting to the Public: Mr. Buddy Casey presented the Council with a poster of the historic WWII Tuskegee Airman and requested that the Council have the poster reproduced and framed.

Mr. John Thomas stated that he is concerned about the discipline problems at the high school. Mr. John Thomas stated that the security guard struck a student and that the principle should have handled the situation.

Chief Dudley reported that he had a meeting with the parents concerning violence at the high school. The School Board contracted Midfield Police Department to provide private duty policing. Chief Dudley stated that they are making a lot of progress and that two arrests were made.
