



The City Council of the City of Midfield, Alabama met in regular session on Monday, June 11, 2007, at 7:30 P.M. with Mayor Gary Richardson presiding.

Councilmember Janice Anderson gave the invocation.

Cedric M. Brown called roll. The following members were present: Terry Adams, Janice Anderson, Reginald Wilson, Jimmie Robinson, Velma Johnson, and Mayor Gary Richardson. Cedric M. Brown acted as clerk. A quorum being present the meeting was opened for the transaction of business.

Approval of published minutes from last Council meeting: Councilmember Janice Anderson made the motion to approve the published minutes from the last regular Council meeting. The motion was seconded by Councilmember Velma Johnson. All members present voted aye passing the motion unanimously.

He informed everyone that the final piece of the City's Master Plan would be unveiled and the update of the Kia Building renovation would be presented. He presented a plaque to Alfred Curtis, who retired after 30 years of service in the Street and Sanitation Department.
