



Meeting Minutes City of Midfield, Alabama City Council

The City Council of the City of Midfield, Alabama met in regular session on Monday, July 22, 2013 at 7:00 pm with Mayor Gary Richardson presiding.

Rev. Dumas presented the invocation. Mayor Gary Richardson led attendees in reciting the Pledge of Allegiance.

Tameeka Vann acted as clerk and conducted a roll call. The following persons were present: Councilor Terry Adams, Councilor Janice Anderson, Councilor Velma Johnson and Councilor Jimmie Robinson. Absent Councilor James Reasor.

Approval of Agenda: Councilor Janice Anderson made a motion to approve the agenda. The motion was seconded by Councilor Velma Johnson. All members present voted “aye”, passing the motion unanimously.

Approval of minutes from last regular scheduled meeting: Councilor Terry Adams made a motion to approve the minutes from last regular scheduled meeting. The motion was seconded by Councilor Jimmie Robinson. All members present voted “aye”, passing the motion unanimously.

Approval of payment of bills: Councilor Janice Anderson made a motion to suspend the rules for immediate consideration of July No. 2 Bills \$ 106,530.64. Approval of Resolution No. 2013-33: Declaring City Property Surplus & Authorizing Disposal. Councilor Terry Adams made a motion to approve Resolution No. 2013-33. The motion was seconded by Councilor Velma Johnson. All members present voted “aye”, passing the motion unanimously.

Approval of Cost Report Notice: Councilor Terry Adams made a motion to approve the Cost Report Notice. The motion was seconded by Councilor Velma Johnson. All members present voted “aye”, passing the motion unanimously.
