The City Council of the City of Midfield, Alabama met in regular session on Monday, July 25, 2011 at 7:00 pm with Mayor Richardson presiding.

Council-member Velma Johnson gave the invocation.

Tameeka Ephriam called roll. The following members were present: Terry Adams, Jimmie Robinson, Reginald Wilson, Janice Anderson and Velma Johnson. Tameeka Ephriam acted as clerk. A quorum being present the meeting opened for transaction of business.
