



Meeting Minutes City of Midfield, Alabama City Council

The City Council of the City of Midfield, Alabama met in regular session on Monday, July 27, 2009 at 7:00 P.M. with Mayor Richardson presiding.

Councilmember Terry Adams gave the invocation.

Tameeka Ephriam called roll. The following members were present: Reginald Wilson, Velma Johnson, Terry Adams and Jimmie Robinson. Tameeka Ephriam acted as clerk. A quorum being present the meeting was opened for the transaction of business.

Approval of published minutes from last Council meeting: Councilmember Velma Johnson made the motion to approve the published minutes from the last regular Council meeting. The motion was seconded by Councilmember Terry Adams. All members present voted aye passing the motion unanimously.

Approval of payment of bills: Councilmember Velma Johnson made a motion to suspend the rules for immediate consideration and pay July #2 bills for \$27,757.77.
