Approval of Agenda: Councilor Wendy Merriweather amend the agenda to add 6 A. Ordinance 2017-01. An Ordinance amending the Municipal Code of the City of Midfield, Alabama establishing requirements and standards pertaining to vehicle impact protection measures for buildings having parking areas within 10 feet of the front entry of the building.
