JULY 25, 2022

Regular Council Meeting

The City Council of the City of Midfield, Alabama met for a regular council meeting at City Hall on Monday, July 25, 2022 at 6:02 p.m. with Mayor Gary Richardson presiding.

- 1. Councilor Terry Adams provided the invocation.
- 2. Mayor Richardson led the Pledge of Allegiance.

- 4. **Approval of Agenda:** Councilor Anderson made motion to approve the agenda. The motion was seconded by Councilor Johnson. A voice vote was taken. All present voted aye and there was no opposition. Motion passed; agenda was approved unanimously.

Awaiting approval of the request for assistance from Jefferson County for funds to purchase another rescue vehicle.
- Tyrone Lloyd, Public Works Director- reported that they are working to get caught up on their routes and duties around the city. Summer Lunch Program has ended. The city's splash pad is open Tuesday, Wednesday, Thursday and Saturday from 10am to 6pm. City Clean up Event is August 10, 2022.
