ORDINANCE NO. 2014-3

BE IT ORDAINED by the Mayor and City Council (herein together called "the Council") of the CITY OF MIDFIELD, ALABAMA (herein called, the "City"). as follows:

Section 1. Finding. The Council has found and ascertained and does hereby declare that Resolution 2014-6, adopted by the Council on February 5, 2014 called for a special election to be held in the City on April 8, 2014, for the purpose of determining the will of the qualified electors of the City on the following question:

Shall the governing body of the City shall be authorized to levy and collect each year (beginning with the levy for the tax year for which municipal taxes will become due and payable on October 1, 2014) an additional annual ad valorem tax of \$1.40 on each one hundred dollars (14 mills on each dollar) of the assessed value of taxable property within the City, the proceeds of said tax to be used for public safety and general municipal purposes referred to in the notice provided in Section 4 thereof.

that notice of said election in the form prescribed in said Ordinance was published by posting a copy thereof at each of the following public places located in the City: City Hall, Community Center, Piggly Wiggly, Midfield Hardware and Midfield Post Office, said posting being effected on February 6, 2014; that said election was held in the City on April 8, 2014 in all respects as provided in said notice; that the ballots used in said election were in all respects in the form provided therefor in said Ordinance; that the election officials conducting the said election have duly delivered to the City Clerk their respective reports and certificates, which have been duly canvassed by the Council, acting as a board of canvassers, with the following results:

A total of 172 votes were cast "FOR" said proposed \$1.40 on each one hundred dollars (14 mills on each dollar) additional rate of taxation, and a total of 107 votes were cast "AGAINST"

said proposed \$1.40 on each one hundred dollars (14 Mills on each dollar) additional rate of taxation, resulting in a majority of 62% votes cast "FOR" said \$1.40 on each one hundred dollars (14 mills on each dollar) additional rate of taxation.

Section 2. <u>Declaration of Results.</u> Upon the basis of findings contained in the preceding Section 1, the Council hereby declares (a) that the majority of the qualified electors of the City who voted in said election on the question of the levy of said \$1.40 on each one hundred dollars (14 mills on each dollar) additional rate of taxation voted in favor of authorizing the levy of said tax, and (b) that the City is accordingly authorized to levy said tax.

Section 3. Recordation of Canvass. This ordinance, constituting the canvas, declaration and findings of the Council, acting as a board of canvassers, shall be recorded in the proceedings of the Council. Further, the City Clerk is hereby authorized and directed to file a copy hereof in the office of the Judge of Probate of Jefferson County, Alabama.

Section 4. <u>Effective Date</u>. This Ordinance shall become effective immediately upon its adoption and publication as required by law.
