

ORDINANCE NO. 2016-1

MIDFIELD MUNICIPAL COURT AMNESTY PROGRAM


From January 25, 2016 until March 25, 2016, certain unpaid Traffic Citations, Criminal or Municipal Ordinance Violation cases are eligible to be paid and accompanying warrants for Failure to Appear in Court are eligible to be cleared under an amnesty program. To qualify for amnesty the following conditions must be met:

- Fines and/or court costs have been assessed and are delinquent, or
- The Defendant has failed to appear in court to address a traffic citation that can be adjudicated by a magistrate.
- Defendants requesting amnesty must pay all fines, court costs and any restitution owed on the original case and a \$20.00 late fee.

Warrants for Failure to Appear in court to answer charges of DUI, Reckless Driving, or Driving while License Suspended, Revoked or Cancelled are not eligible for withdrawal under the amnesty program.
